MoNamibia nomoilongo ikwao youdemokoli, oikundaneki ngaashi oifonghundana, eeradio, eeTV naikwao, oi na oshinakuwanifwa shakula okukaleka oshiwana shi na ouyelele/sha kundana. Eshi oshilonga sha fimana: Efinamhango lohilongo eshi otali tu ovanhu omukumo va kufe ombinga monghalamwenyo yoshiwana, ndee eshi ovanhu otave shi dulu ashike ngee ova shiiva osho tashi li nyenge.

Osho naana kutya oikundaneki otai dana onghandangala yakula mokuninga oudemokoli woshili, emanguluko loikundaneki shimwe sha fimana moudemokoli nola amenwa kefinamhango lohilongo.

Ngeenge oikundaneki tai dana onghandangala ei, ovatoolinghundana ova pumbwa okulonga nawa pamifika doilonga yavo nokuhe na oulingilingi. Namibia okwa etapo Omulandu woilonga yaavo hava longo noikundaneki okupitila mOlutu lOvatalululi vEenghundana manga inadi pitifwa (moEditor's Forum yaNamibia, oEFN) hau ifanua: "oCode of Ethics" Nomulandu waNamibia ou ou li naana pomufika wopaiwana.

Omulandu ou owa mangela oikundaneki koiteelelwa yophovelo yaasho omutoolinghunana muwa e na okuninga, shoo osho:eenghundana da tova, inadi ama ombinga da manguluka neameno leedjo, eenghundana itadi nyane, naikwao.

O-EFN oya eta po yo omukalo wokuuda nokutokola omanyenyeto oo taa ningilwa oikundaneki. Ombelewa yomupongololi woimbuluma yoikundaneki (media ombudsman) oya totwa, ya totwa oshita nOkomiti

yOmanyenyeto Oikundaneki (oMedia Complain Committee) nOmunashipundi wongudu yokupwilikina komaindilo ngee pen a ou ina tambula ko osho sha tokolwa (Appeals Chairperson).

Eli olutu tali lipangele loo vene li li naana pamufika waasho shiwa hashi ningwa koiwana aische. Oikundaneki yaNamibia oya kufa po oshinakuwanifwa eshi nelitulemo.

Ovanhu ava tava shikula omilandu kave na fiku va ka ye komhangu lwanima. Eshi twa mona fyee vene osha ulika kutya olutu eli tali lilele loo vene olipu nokuhanga, ohali endebele noli na ombilixa li dullife omhangu ngee tai ungaunga nomanyenyeto.

Eshi olutu eli ola kwatela mo Ovatalululi vEenghundana manga inadi pitifwa, ovo tava pangulwa koombushe moilonga, oi na yoo elelo loivina, li na eenghono.

Ombelewa yOmupongololi woimbuluma yoikundaneki paife oya yeulukila ongeshefa (ya hovela oilonga). Ovakhwashiwana otava tuwa omukumo va longife omulandu wokuninga omanyenyeto, opo va shilipaleke kutya Namibia ota kala alushe moudemokoli ou woshili.
